

REGISTRATION-

- 1. Individual participation. Maximum 02 students from a particular course can participate from a said institution.
- 2. Participation is open to students pursuing 2nd Year Pre-University/ 12th grade/ undergraduate/ post-graduate programs in any course from an institution recognized within the territory of India.
- 3. Registration shall be done via Google Form before the given deadline by making necessary payment.
- 4. Last date of registration 25th Feb 2022
- 5. Registration fee applicable- Rs 100 per participation.
- 6. Maximum cap of participants is restricted to 20. Registration beyond the ceiling will be rejected.

POSTER Dimensions & Content-

- 1. Poster size: A3/A4, equivalent to the single one-sided sheet view.
- 2. Focus on the given theme
- 3. One submission per registered participant.
- 4. Write-ups/Slogans supporting posters shall be in legible Font of Hindi/English/ Kannada.
- 5. Acceptable tools for drawing/painting/designing include pencil, crayon, watercolor, oil paint, etc.
- 6. It should be ensured that the uploaded poster is visible along with the text and graphics/image in PDF File format.
- 7. Photographs, wires, other 3D objects, printouts won't be acceptable.
- 8. Posters portraying potentially inappropriate and/or offensive content, including provocative nudity, violence, human rights and/or environmental violation, and/or any other contents deemed to be contrary to the law, religious, cultural & moral traditions, and practices of India, are strictly prohibited and will be immediately discarded.
- 9. No posters shall include an image or name of government officials / popular personalities/ political parties.
- 10. In case of any above instance, the Organizing Committee is at the discretion of withdrawing any submission.
- 11. Participants are required to submit their poster in PDF version only & write up explaining their idea and expression in PDF/MS WORD.

Font - Times Roman, 12

Word limit- 200 max.

SUBMISSIONS-

- **1.** Each participant after the registration will be provided with a Participant Code.
- 2. File Format: Save your file as a PDF for quick and easy upload, named per the code given.
- 3. Submissions will not be accepted once the deadline lapses.
- 4. Any Poster submission violating the rules and regulations shall be disqualified.
- 5. In the case of any dispute with regards to the winning position, the decision of the jury will be considered final.
- 6. The submissions will be posted on CEWCL Instagram handle (@ashmita_fightfordignity). 25% weightage of marking shall be given to the likes on the post and 75% on originality, creativity, presentation, and theme relevancy.

JUDGEMENT

SUBMISSION GUIDELINES FOR PHOTOGRAPHS

1. With the main focus on the given theme, there must be one submission per participant.

Dimensions-

- a) The photo must be at least 1,600 pixels wide or tall (if horizontal or vertical image respectively)
- b) File size shall not exceed 10 megapixels.
- c) Photos may be black & white or colour, JPEG, PDF, or PNG.
- 2. All entries must be high-resolution digital images.

Submissions-

Participants are required to submit their photographs with a unique title & description for the image submitted in MS WORD DOCUMENT Font - Times Roman, 12

Word limit- 200 max.

- 3. Submissions are to be made through the mail with File Named per the participant code.
- 4. Submissions will not be accepted once the deadline lapses.
- 5. The same photo can be submitted for more than one contest.
- 6. There must be no border(s), logo(s), copyright marks, identifying marks, or any other visible references and/or marks on the image.
- 7. Basic editing, including colour enhancement, the use of filters, and cropping of the Photo(s) is acceptable, provided any such editing does not affect the authenticity and/or genuineness of the Photo(s).

- 8. Advanced editing is used to create illusions, deceptions and/or manipulations, and the adding and removing of significant elements within the frame is prohibited.
- 9. Every image uploaded is subject to a moderation process before it becomes visible on the contest page.
- 10. The submissions will be posted on CEWCL Instagram handle (@ashmita_fightfordignity). 25% weightage of marking shall be given to the likes on the post and 75% on originality, creativity, presentation, caption and theme relevancy.
- 11. CEWCL reserves the right to assess and disregard any submitted photo at its discretion.
- 12. Photos and submissions that portray or otherwise include inappropriate and/or offensive content, including provocative nudity, violence, human rights and/or environmental violation, and/or any other contents deemed to be contrary to the law, religious, cultural & moral traditions, and practices of India, are strictly prohibited and will be immediately discarded.
- 13. A participant on non-abidance of the above-mentioned rules may become subject to disqualification at CEWCL's discretion.

DEBATE COMPETITION

in association with DebSoc, IFIM Law School

1. STRUCTURE -

- The Competition will consist of two rounds Preliminaries & Finals.
- Teams of 3 will be matched-up in a random pattern to face off against each other in the Preliminary Round.
- Preliminary round debate shall consist of three Speeches from one side. Each speech shall last 4 minutes, followed by 5 minutes for Judges' Q&A.
- Final round debate shall consist of three Speeches from one side. Each speech shall last 7 minutes, followed by 5 minutes for Judges' Q&A.


2. TOPICS/MOTIONS -

- The teams will be provided 3 topics/motions on 5th March 2022 i.e one day prior to the preliminary round of the Competition. The topic for the debate will then be decided through a coin toss by the Moderator before the round begins. The winner of the toss will select one of the three topics which will be the Motion for that debate and the other team can select which side they want (Affirmative/Government or Negative/Opposition).
- The topics/motions shall be policy-based and related to the theme "Bodily Autonomy for women"
- There will be a separate, single topic/motion for the Finals which will be announced on 6th March 2022 after declaring Preliminary round results.
- Teams are advised to research and come prepared for both sides in Preliminary round for all three topics/motions.

3. RULES -


- The Moderator will keep track of the time and the order of the speeches. They will be there to assist the Judges and Teams in case of any technical difficulties.
- Participants are requested to keep their video switched on throughout the Rounds and maintain decorum, without disturbing the other speakers. Speakers must unmute only upon request and shall otherwise remain on mute.
- Points of Information or POI shall be entertained and can be asked via the chat box, without disrupting the flow of the speaker. The Speaker is at liberty whether or not to take it up.
- There shall be no reply speeches.

6. SCORING -

- The Teams will be ranked based on their scores. Each team's total score will be the aggregate of their 3 Speaker scores.
- The top two teams with the highest scores at the end of the Prelim will then contest in a Final round to decide the winner.
- In case of any tie, the Judge's discretion will be taken into consideration and any decision made by the Judges shall be final & binding.

7. MODE & LOGISTICS -

- The Competition will be held on Zoom and the links shall be provided to the Registered Email ID of the Participants.
- All Preliminary rounds shall be held simultaneously either via Break-Rooms or on multiple Zoom meetings.
- Each debate will have two Judges, two Teams and one Moderator.
- The Finals will be held on 8th March 2022.

8. REGISTRATION-

- Participation is open to students pursuing Pre-University/ 12th grade/ undergraduate/ post-graduate programs in any discipline from an institution recognized within the territory of India.
- Registration shall be done via Google Form before the given deadline by making necessary payment.

- Maximum cap of participants is restricted to 08. Registration beyond the ceiling will be rejected.
