
Objective of Law Society

DETAILED RULE BOOK FOR JUSTITIA 2022

MEDIATION COMPETITION

Alternate Dispute Resolution is one of the most important aspects of justice delivery in present day. Mediation forms one of the most crucial aspects of it. The competition seeks to simulate a bipartite mediation between teams based on some common facts and different confidential information privy to each side. In a mediation procedure, a neutral intermediary, the mediator helps the parties to reach a mutually satisfactory settlement of the dispute. Any settlement is recorded in an enforceable contract.

Courtroom: The Law Society of CLS, GIBS presents its Mediation Competition in Collaboration with North District Legal Service Authority, Maheshwari & Co. and Indian Institute of Arbitration and Mediation.

Best Team Award: Cash Prize of Rs. 10000/- + Trophy + 1 month internship

Runner Up Award: Cash Prize of Rs.7500/- + 1 month internship

Detailed Rules

CHAPTER I – INTRODUCTION

1. Short Title and Commencement

- a) These rules may be called 'MEDIATION RULES & PROCEDURE, 2022'.
- b) They shall come into force from the date of publication, on the official website of GIBS.

2. Definitions

In these rules, unless the context otherwise requires:

a) "CLS, GIBS" refers to Centre for Legal Studies, Gitarattan International Business School (hereinafter referred to as "CLS, GIBS"), affiliated to Guru Gobind Singh Indraprastha University.

- b) "Qualifying Rounds" refers to Preliminary Round I and Preliminary Round II of the Competition.
- c) "Advanced Rounds" refers to Semi-final and Final rounds.
- d) "Clarifications" refers to the queries arising out of the mediation problems that would only be accepted and reverted to in the timeline prescribed.
- e) "Competition" refers to the 2nd Mediation Competition at CLS, GIBS.
- f) "Institute" refers to the Centre for Legal Studies, Gitarattan International Business School (hereinafter referred to as "CLS-GIBS"), affiliated to Guru Gobind Singh Indraprastha University.
- g) "Judge" refers to a professionals selected by the Organizing Committee to evaluate and score the teams' performances during a mediation session in accordance with the judging criteria.
- h) "Mediating Pair" refers to the client and counsel pair of the participating team.
- i) "Mediation Session" refers to the timeframe for each round as specified in the rules below.
- j) "Mediator" refers to the third member of the Mediating Team who has applied and registered for the Competition as a participant.
- k) "Organizing Committee" refers to the body of student-faculty-staff of CLSGIBS and includes any other person, appointed by the Institute for the administration and functioning of the Competition.
- "Participants" refers to and includes only the bona-fide representatives of the University/
 College/Institute who have applied and registered for the Competition by complying with
 the procedure prescribed hereinafter.
- m) "Requesting Party" and "Responding Party" refer to the competing team which argues on behalf of the party requesting the Mediation and the party responding to the request for Mediation at any given point in the Competition.
- n) "Team" refers to the Mediating Pair and Mediator representing their Institute.
- o) "Team Code" refers to the unique number allotted to the Team which would be used to identify them throughout the Competition.
- p) "Caucus" refers to the private meeting that each party holds with the mediator during the mediation. These private meetings give participants a chance to talk to the mediator freely, without the pressure of the other party being there. Anyone participating in mediation may request a caucus, including the mediator.

3. Interpretation

The Organizing Committee shall reserve the right to interpret the rules as it may deem fit in the interests of the participants and the organizers to maintain fairness and equality in the Competition. The interpretation placed upon these Rules & Procedure shall be conclusive and the decision of the Organizing Committee regarding the application of these Rules & Procedure shall be final. Any such decision shall be binding on all the stakeholders and participants.

CHAPTER II - REGISTRATION

4. Eligibility

Students pursuing their full time 3-year LLB or 5-year LLB program (1 team per program per institute) from a university or Institute recognized by the Bar Council of India, are eligible to apply.

5. Number of Teams

Subject to the provisions of this Chapter, the Organizing Committee shall accept the registration of a maximum of **24 teams** on first come first serve basis.

6. Registration Process

- a) The Mediation Competition will be conducted in the offline mode.
- b) The participants are required to register as a team of 3 students viz, a Mediating Pair (Client and Counsel) and a Mediator.
- c) The payment of registration fees amounting to Rs. 2700/- per team shall be made by the prescribed payment procedure. Registration fee is non-refundable in any case.
- d) The participating team shall mandatorily email a scanned copy of the duly completed Registration, Payment Form and Authorization Letter along with the receipt of payment on mediation@gitarattan.edu.in
- e) The participants must mail the payment screenshot/receipt to mediation@gitarattan.edu.in
- f) Registration will not be allowed without authorization Letter from the college.
- g) The Organizing Committee shall send a confirmation of participation email after verifying the entire process as enlisted under the aforementioned clauses.

h) Any failure or non-adherence with the aforementioned procedure may be treated as withdrawal from the competition and no claim of whatsoever nature shall be entertained thereafter.

CHAPTER III - THE COMPETITION

7. Format of the Competition

- f. The Mediator(s) are permitted to call for both, caucuses and conferences, whichever he/she may deem fit in the interest of the parties. Provided that the disputing parties may request the Mediator(s) to conduct a caucus.
- g. Team(s) may carry and use its own prepared notes for its own use and may, if need be, make its own notes during the Mediation Session. All notes must be written on paper.
- h. Usage of electronic devices during the session is strictly prohibited. No audio or videotaping of Mediation Sessions is permitted. Photography during the Mediation Session is also forbidden.

Last date to seek clarifications is 16th November 2022 and the release of such clarifications would be on 17th November 2022 via the official email id of lawolympiad@gitarattan.edu.in in a document form.

6. Winners

- b) The participant with the highest score shall be declared as the "Top Scorer".
- c) The participant with the second best score shall be declared as the "2nd Best Scorer".
- d) All winners will be awarded Cash Prize and an E- Certificate of Merit.

CHAPTER III- MISCELLANEOUS

- a) The Organizing Committee shall have power to amend, modify or revoke the provisions of these rules, either in part or in whole, subject to the feasibility, transparency and smooth functioning of the Competition.
- b) Use of mobile or other electronic instruments during the event is strictly prohibited and any candidate found engaging in such activities shall be immediately disqualified.
- c) The candidates are requested to ensure a stable internet connection with a workable microphone and camera throughout the competition.
- d) The above-mentioned rules of the competition should be strictly adhered to. Any deviation from them would attract disqualification or other penalties as decided by the organizers.
- e) Decisions taken by the organizers in case of any dispute, doubt, or disqualification shall be final and binding.

Detailed Rules

CHAPTER I- REGISTRATION

1. Eligibility

Students from all over India pursuing an eligible course either law/non-law may participate in the Youth Parliament.

2. Number of teams

The Organizing Committee shall accept the registration of a maximum of **40 participants** on a first come first serve basis.

3. Application process

- a) Students from all over India pursuing an eligible course either law/non-law may participate in the Youth Parliament.
- b) The competition will take place on $23^{rd} 24^{th}$ November 2022. The detailed schedule for the event is mentioned below.
- c) There can be multiple entries from each college/institution.
- d) Entries will be entertained without an authorization Letter from the colleges/institutes/university.
- e) The participating team shall mandatorily email a scanned copy of the duly completed Registration and Payment Form along with the receipt of payment on youthparliament@gitarattan.edu.in
- f) The Organizing Committee shall send a confirmation of participation email after verifying the entire process as enlisted under the aforementioned clauses.

g) Any failure or non-adherence with the aforementioned procedure may be treated as withdrawal from the competition and no claim of whatsoever nature shall be entertained thereafter.

4. Registration procedure

- a) The registration fee for the competition is Rs. 600/- per participant.
- b) Each team shall register themselves through the registration form via link provided.
- c) The amount paid (registration fees) shall be non-refundable.
- d) Interested candidates must register themselves latest by 1st November 2022.

CHAPTER II-THE COMPETITION

5. Format and procedure of the competition

- a) The competition will be held across a span of 2 days i.e. $23^{rd} 24^{th}$ November 2022.
- b) Lok Sabha is the only committee that would be in working during Youth Parliament.
- c) Portfolio-
 - Delegates shall mention their portfolio preferences in the registration form. CLS,
 GIBS holds the authority for allocation of portfolios and delegates shall be notified with the portfolio via official email id.
 - Portfolios will be given on the basis of prior experience.
 - Once the portfolio is provided the delegate would be provided with a background guide by an email from CLS, GIBS. If the delegate doesn't receive the mail they shall inform the organizing team of CLS, GIBS prior to the competition. The organizing committee shall not be responsible if the information is not provided.
 - No request for the change of the portfolio would be entertained.
- d) Only Governmental/Parliamentary/Law Commission Reports/ International Reports would be taken as official. Other Newspaper reports, International Reports, NGO findings/Studies, etc. can be brought up for debate but would hold no official value.
- e) Rules of Procedure-
 - Roll Call

The Lok Sabha Speaker will take the attendance before the sessions starts through roll call and the members have to give their attendance as "Present" on their microphone. Roll Call will be taken on the member's portfolio before

the start of session on both the days and all the members are to take part in the Roll Call.

Note to Delegates: As the session begins in committee all the delegates will be identified by their allotted portfolios and not by their own name. For smooth functioning of committee delegates are hence expected to maintain the anonymity.

• Opening Statements

The Opening statement will be presented by the Minster in Charge (MIC) before the House. After his presentation further statement will be allowed on the floor from the members by the Speaker of the House.

The members will be delivering an opening statement after the presentation of MIC. The default speakers' time for this shall be 120 seconds can be extended up to 180 seconds.

After every speech, members are obligated to yield the floor back to the Executive Board/Speaker.

The Executive Board/Speaker will direct the members to submit statements.

The number of statements to be submitted will be decided by the Executive Board/Speaker depending on the time.

The option of raising placards of their respective portfolios would be used by the delegates to speak up.

• Establishing the sessions

The session will be established by passing an order by the Speaker of the House for public session.

• Public Session

In order to discuss various sections of the agenda, a separate time frame is allotted for the members to put their views on the floor of the house.

A public session can be of 120 minutes but the individual speaker's time will be maximum 2 minutes 30 seconds only.

As the public session is open for general visitors and in presence of the media, the members are requested to maintain parliamentary decorum.

Zero Hour

Students are quite accustomed to see members of Parliament asking questions during the Question Hour. That's how Parliament begins its day when it's in session. Apart from the Question Hour, Parliament allocates additional time slot for the members to discuss issues.

Zero Hour – Rules & Regulations for the purpose of this conference Members wishing to raise matters of public importance during the "Zero Hour" need to give notice to the executive board before the Zero hour starts. The notice should clearly state the subjects they want to raise. The executive board is the final authority that can either reject or accept such request.

Minimum 12 and maximum 20 matters will be allowed to be raised during the Zero Hour. Again, it is the executive board who decides which subjects are to be discussed and in what order.

The total time allocated for Zero Hour would ideally be 2 hours wherein a member gets three minutes to raise the issue. Moreover, a member is allowed to make only one Zero Hour request.

Question Hour

The question hour will be of 2 hours in total where each speaker's timing will be decided by the Speaker/EB.

The members are urged to listen carefully to whatever statements are made by different members throughout the day and send the questions through chits to the speaker right from the start of session till the question hour begins.

The questions can pertain to anything discussed in the short period discussions or something said during the opening statements. The members should restrict their questions to the agenda at hand.

The discussion will be on the topic placed by the MIC in the opening statement.

f) Points

• Point of Personal Privilege (PP)

A Representative may rise to a Point of Personal Privilege if a matter impairs him/her from participating fully in council activities.

The Executive Board persons shall try to effectively address the reason of impairment.

Personal Privilege may only interrupt a speaker if the Representative speech is inaudible. Otherwise, the Representative rising on the Point of Personal Privilege must wait till the end of the speech to raise the Point.

The member should raise his/her placard to the EB to take part in Point of Personal Privilege during Question Hour. Speaker/ EB will allot time to each applicant speaker according to the session time available.

• Point of Order (PO)

A Representative may rise to a Point of Order if he finds a factual flaw in the speech of the delegate speaker (Through message to the EB).

This point may not interrupt the concerned delegate speaker.

The Executive Board will rule on the validity of the point immediately (Through chits sent to them by concerned delegates).

A Point of Order ruled dilatory by the Executive Board may not be appealed.

• Point of Information (PI)

A Representative may rise to a Point of Information if he/she wishes to ask a question or clarification to the delegate speaker.

This point may not interrupt a delegate speaker.

This point is only valid at the time of the opening statements.

• Right of Reply (RR)

A Representative whose personal integrity has been impugned by another Delegate's comments may rise to a Right of Reply.

Disagreement with the content of a Delegate's speech is not grounds for a Right of Reply.

The Executive Board will recognize the Right of Reply at his/her discretion as well as decide on how to resolve the motion.

Right to reply may not interrupt a delegate speaker but should be addressed the moment he/she has finished his/her speech.

Executive Board shall formulate the rules for Right of Reply (out of order), his/her decision cannot be appealed.

No Representative may call for a Right of Reply on a Right of Reply.

"PLEA TO FOLLOW UP" is the request appealed to EB for the continuation of cross question/cross answer after a reply.

Replies can be either oral or written. It is to be noted that if delegate needs the chit to get marked he/she may pass the chit via EB.

• Point of Parliamentary Inquiry (PPE)

A Representative may rise to a Point of Parliamentary Inquiry requesting an explanation/repetition from the Executive Board on the Rules of Procedure. This point may not interrupt a Speaker.

Important Points

- For all the starred questions, the delegates are requested to send their chits to EBs with a prefix of '**'.
- For all the un-starred questions, the prefix of 'Bulletin' would be used by the delegates.
- Also, while getting any type of privileges or exercising any parliamentary rights, the abbreviations mentioned along, above must be used. For e.g. Right to Reply should have a prefix 'RR'.
- Any chits received without the prefix will not be considered.
- Any chit without mentioning TO WHOM it is referred will not be considered for marking.
- Delegates who are willing to get their chit scored should pass the chit via EB, chits which are not passed through EB will not be marked.
- Any unparliamentarily behaviour would lead to a strict action against the delegate.
- For the registration to be completed the screenshot of the payment confirmation page is to be sent on the given e-mail with respective names, college name and contact number and send it is a prerequisite.
- To ensure a successful and smooth functioning of committee and even the session will have moderators who can be approached for any help and the numbers of coordinators given below are for the ease of delegates if they encounter any problems.

7. Language

Lok Sabha would be a bilingual committee wherein members can speak either Hindi or English. English shall be the official language for the purpose of drafting.

9. Dress Code

- a) The dress code for the Competition shall be business formals or in accordance with the portfolio for both male and female participants.
- b) The dress code shall be business formals for Inaugural and Valedictory Ceremony.

10. Winners

- a) Results will be declared in the Valedictory Ceremony on 24th November 2022.
- b) All winners will be awarded Cash Prize and a Certificate of Merit and every participant shall be awarded a Certificate of Participation.

CHAPTER III- CODE OF CONDUCT

11. Code of conduct applicable to participants

- a) All the participants are bound to follow the code of conduct and the rules lay down by the organizing committee.
- b) Any behaviour of indiscipline with the Judges, Organizing Committee, any other staff member or student volunteer shall be dealt with strictly and may lead to immediate disqualification from the Competition without scope of appeal.
- c) Any kind of nuisance, vulgar language, and non-parliamentary language would directly lead to disqualification.
- d) Any attempt to approach the framer(s) of the problem(s) or the panel of Judges of the Competition, prior to the Competition shall lead to immediate disqualification from the Competition without scope of appeal.
- e) All or any grievances are to be presented only to the grievance committee of the competition and the decision of the grievance committee shall be final and binding on the participants.

12. Anonymity of Participants

- a) The delegate must represent themselves with their respective portfolio names and not by their own names.
- a) No participant shall reveal their identity in any form during the Competition.
- b) Any violation of the provisions of this rule shall attract severe penalty or disqualification as determined by the Organizing Committee. The decision of the Organization Committee in this regard shall be final and binding without scope of appeal.

CHAPTER IV- MISCELLANEOUS

- a) The Organizing Committee shall have power to amend, modify or revoke the provisions of these rules, either in part or in whole, subject to the feasibility, transparency and smooth functioning of the Competition.
- b) Any such amendment or modification shall come into force upon the notification of such amendment or modification as the case may be. Any such amendment or modification shall be deemed to be part of these rules.
- c) Use of mobile or other electronic instruments during the rounds is strictly prohibited and any candidate found engaging in such activities shall be immediately disqualified. No audio or videotaping of any round is permitted.
- d) The organizing committee shall have sole discretion to assess penalties or to disqualify teams for any failure in abiding by any of the foregoing Rules.
- e) The decision of the Judges and the Institution on any issue arising during the competition shall be final and binding.
