Environmental Law

### **MODE OF THE COMPETITION**

- The Preliminary round, quarter-finals round, quarter-finals round, and Semi-finals round shall be conducted online via Zoom Webex/Gmeet.
- Final Round shall be physically conducted in the 'Perungudi' campus of The Tamil Nadu Dr. Ambedkar Law University. For international teams qualifying for Finals, special provisions to join virtually will be made.

### **OFFICIAL LANGUAGE**

The official working language of the competition is English.

### **ELIGIBILITY AND TEAM COMPOSITION**

- Participation is strictly restricted to bona fide law students enrolled in the three years or five-year LLB or BL degree course in any institution recognized by the Bar Council of India.
- Only **one team** is permitted to participate from each registered institution.
- Each team shall comprise of a minimum of two and a maximum of three members. In a team consisting of two members, each of the members shall be designated as 'Speaker'. In a team consisting of three members, two of the members shall be designated as 'Speaker' and the third member shall be designated as 'Researcher'.
