




SUBMISSION GUIDELINES

- Submissions shall be made in the online mode only. Font size 12, Times New Roman, Justified, 1.5 spacing, Margins 1 inch
- Submissions shall be in English.
- Submissions need to be original. Plagiarism shall result in disqualification. Similarity percentage: 10-20 per cent depending on the quality of submission
- Co-authorship is permitted up to a maximum of two authors.
- The name and affiliation of the author/co-author shall be attached separately in the mail while submission and not in any manner as part of the essay. Any identification mark (in any form) in the essay shall lead to disqualification.
- Multiple or incomplete submissions shall not be considered.
- Word limit: Min 1200 words to Max 1800 words (excluding references).
- Submissions below or above the word limit shall not be considered.
