- 2. ARTICLES: Focused discussions on emerging trends, challenges, or perspectives ranging from a word count of 3000- 4000 words. Coauthorship is not permitted.
- 3. CASE LAW ANALYSIS: Critical examinations of specific legal cases ranging from a word count of 2000-3000 words. Co-authorship is not permitted.

#### **SUBMISSION GUIDELINES**

- 1. All submissions must include an abstract that does not exceed 250 words and includes keywords.
- 2. The authors shall submit their manuscripts through this Google form only. Submissions made through any other mode shall not be accepted.









- 3. Language: The submissions shall only be accepted in English.
- 4. Formatting Guidelines

a)The body of the submissions must be in accordance with the following specifications:

Font - Times New Roman

Font Size - 12


Line and Paragraph Spacing - 1.5
